

March 30: COVID-19 Clinical Update New Testing Criteria, Telemedicine Prescribing Guidelines, Donations and CDC Chloroquine Alert

To facilitate the sharing of important clinical information during the COVID-19 healthcare crisis and to help respond to questions from physicians across the health system, Northwestern Medicine has implemented a new daily communication for physicians – the COVID-19 Clinical Update.

In today's issue, you will find information regarding new COVID-19 testing criteria that went into effect on March 28, new telemedicine prescribing guidelines, how to manage donations and a CDC health advisory about chloroquine phosphate.

NEW COVID-19 TESTING CRITERIA

Because of limited COVID-19 testing supplies across the country, and to ensure adequate supplies needed to continue to test hospitalized patients and our workforce, Northwestern Medicine made the decision to suspend outpatient testing until additional supplies become available. All alternative testing site operations have been suspended. While outpatient testing has been suspended, we will continue to support our patients by adapting COVID-19 assessment and testing criteria. CDC CHLOROQUINE HEALTH ALERT

A March 28 health alert from the U.S. Centers for Disease Control and Prevention (CDC) states that chloroquine phosphate, when used without a prescription and supervision of a healthcare provider, can cause serious health consequences, including death. Clinicians should discourage patients from misusing non-pharmaceutical chloroquine phosphate (a chemical used in home aquariums). Clinicians should advise patients that chloroquine, and the related compound hydroxychloroquine, should be used only under the supervision of a healthcare professional as prescribed medications.
