Dr. Rosado graduated from Universidad La Salle School of Medicine in Mexico City, Mexico. In 2004, Dr. Rosado joined the Division of Child Protective Services at John H. Stroger, Jr. Hospital of Cook County and the Chicago Children's Advocacy Center, where he completed medical evaluations for children seeking asylum in the U.S. He worked as a consultant pediatrician for the Child Protection Team at Starship Children's Hospital in Auckland, New Zealand in 2010, and in 2013, he joined the Division of Child Abuse Pediatrics at Ann & Robert H. Lurie Children's Hospital of Chicago, where he has served as division head since 2020. He is board-certified in general pediatrics and in child abuse pediatrics.
