Important Reminders

- When donning and doffing PPE, take special care to follow CDC Donning and Doffing Guidelines to not contaminate yourself in the process.
 - o Donning reminder: perform an N95 respirator seal check prior to entering the room. Tie gown in the back.
 - O Doffing reminder: grasp gown at the front and pull away slowly and carefully, rolling inside out while taking your gloves off at the same time. Do not touch front of goggles, face shield or N95 respirator while doffing.
- Standard hospital-approved disinfectant wipes are appropriate for disinfecting equipment and surfaces.
- All procedures should be performed at the bedside. For any procedure that cannot be performed at the bedside, patient must be transported in a surgical/procedure mask with a clean patient gown and clean bedding. Receiving departments must be notified of patient's isolation precautions.
- Linen requires no special handling.
- Food can be served on regular trays and do not require any special disposal.
- Visitors are not permitted. Any exceptions must be approved by Infection Prevention. If an exception is made, visitors must wear a surgical mask, gown, gloves, and goggles or face shield.
- Communicate with EVS if waste containers in patient room and anteroom are three-fourths full. Trash and linen bags must be secured prior to removal from patient room.
